Sales Tax on Service Repeal Needs Grassroots Campaign January 27, 2011

A major victory for LANJ, the New Jersey Senate passed the "Repeal of the Sales Tax on Service" by a 37-0 vote on January 10. Now attention must be given to finding a similar victory in the New Jersey Assembly. LANJ members are urged to contact their respective assemblyman/woman to ask for his/her support of the bill as soon as the Assembly bill number is advised (anticipated within a few weeks).

Without it, it will be very difficult to get the majority vote necessary (2/3 vote in the Senate and 2/3 vote in the Assembly) to convince the Governor to sign the bill or to overcome his veto (should that be the outcome).
