LANJ, Matt Daus and Lancer Insurance Work Together November 23, 2011

Ever since Matt Daus left as commissioner of the New York City Taxi Limousine Commission (NYC TLC), the chauffeured transportation industry has been confronted with numerous new rulings and regulations that have created havoc for operators. Daus, now general counsel for LANJ, previously had been successful on behalf of LANJ with the TLC in eliminating the issue of window tinting violations. The newest TLC issue that has put operators' ability to do business in New York City in jeopardy is the demand that liability insurance policies carry \$200,000 of personal injury protection (PIP) coverage. While New Jersey operators that have \$250,000 coverage bus policies have specific language referring to PIP in the policies, New Jersey requirements do not specifically require PIP language for non-bus operators' policies.

This past Friday Daus, also general counsel for Lancer Insurance Company, met with TLC general counsel and staff members about this concern and found that the TLC does recognize the Lancer ISO Line-of-Insurance Program as meeting the PIP requirements. Should you have a different carrier than Lancer, however, it is recommended to have the carrier electronically send a copy of the ISO form and contact person name to <u>barry.lefkowitz@mgr-lobbyist.com</u> to see if it parallels the Lancer ISO form. If it does, the TLC will recognize the policy as providing the proper PIP coverage and register the vehicles. If it does not, it is recommended that your carrier speak with Daus regarding how to get into compliance.

COTA Flexes Its Muscle for the Industry

The Coalition of Transportation Associations (COTA), a group of New York and New Jersey membership organizations including the Black Car Assistance Corp (BCAC), Limousine Association of Long Island (LALI), the Limousine Association of New York (LANY), the Luxury Base Operators Association (LBOA) and LANJ, led by Matt Daus was formed to:

- Advance, support and preserve the integrity and economic viability of the for-hire ground transportation industry in the region;
- Promote environmental sustainability;
- Foster job growth and inter-modal transportation solutions;
- Support reasonable government regulation; and
- Enhance customer service and explore viable advances in technology to assist businesses, passengers and the industry.

Recently, COTA scored its first major victory with the NYC TLC. The TLC proposed rules to amend For Hire Vehicle (FHV) requirements to permit vehicles altered after manufacture to be used as FHVs in NYC. Unfortunately, the suggested rules were not properly vetted with the chauffeured transportation industry, manufacturers and insurance carriers e.g. vehicles transporting 16-20 passengers must carry \$15 million insurance coverage per occurrence. We know of no insurance company that has a policy with that amount of liability coverage. Obviously they did not speak to the insurance carriers.

COTA, represented by Matt Daus, was able to advise the TLC of this inaccuracy and set the stage for appropriate rules to be established instead. In addition, TLC Commissioner David Yassky has agreed to meet with COTA quarterly to discuss issues and concerns so that the industry and the regulators can work together going forward.
