## LANJ Addresses Issues with Jersey City and Hoboken May 31, 2012

On May 25 LANJ president Tim Rose, legislative chair Jeff Shanker and executive director Barry Lefkowitz held a conference call meeting with New Jersey Motor Vehicle Commission chief administrator Raymond Martinez, deputy administrator Selika Gore and director Denise Coyle. Jersey City and Hoboken have passed ordinances in violation of state law that specifically indicates only a \$10/vehicle charge for chauffeured transportation companies is permitted. The Motor Vehicle Commission (MVC) representatives acknowledged recognition of the problem and discussed two potential avenues to address it: 1) The MVC can send a letter to the two municipalities informing them they are violating the law; and/or 2) The MVC legal counsel can investigate the ordinances and possibly go to the attorney general to take action. Additionally, Assemblyman Charles Mainor (D) from Jersey City, who is a member of the Assembly Transportation Committee, is interceding with the municipal officials on behalf of LANJ members and will set up a meeting between the governing and regulatory bodies and LANJ leadership.
