On Friday September 21 nearly 200 members of the industry participated in the First Annual Coalition of Transportation Associations (COTA) Industry Summit, held at the Four Point Sheraton in Long Island City. NYC TLC Commissioner David Yassky swore in the members of the COTA board of directors including president/board chair Mathew Daus (Windels Marx), Berj Haroutunian (BCAC), Jeff Rose (LANY), Tim Rose (LANJ), Sergio Sanchez (LBOA) and Doug Schwartz (LILA) and officers including first vice president Sergio Sanchez, second vice president Doug Schwartz, vice president of government affairs Barry Lefkowitz, treasurer Ira Goldstein and secretary Bill Carter.

Topics discussed at the Summit included: "How to Protect Your Business from Rogue Smartphone Apps," "Marketing and Customer Service," "Base and Driver Affiliation Agreements" and "Trade Associations and Government Affairs." The featured guest speaker was the Hon. Bill de Blasio, New York City public advocate and potential mayoral candidate.

Ninety LANJ members were recently trained at the Clarion Hotel in Princeton with the director of New Jersey Homeland Security and his staff for "Threat Assessment and How to Recognize It." Of note, 39 terrorist attempts have been thwarted in the greater New Jersey region since 2009. There are discussions with Homeland Security about potentially conducting a workshop at the Limo Digest Show.

#### **Efforts to Deal with Jitney Crisis Intensify**

As previously published in **E-News**, LANJ has been seeking a solution to prevent jitneys from performing chauffeured transportation-type services beyond their legal status. Their activity is hurting LANJ operators throughout the New Jersey southern region and in certain northern New Jersey cities. On September 25 a meeting was held at the State House with Assemblyman John Wisniewski, chairman of the Assembly Transportation Committee. Chairman Wisniewski, in turn, has promised to discuss this matter with Assemblyman Charles Mainor (D-Jersey City) who is a member of the Transportation Committee and to ask him to join on as a prime sponsor of corrective legislation that can be presented to the Committee this fall.
