LANJ Board of Directors Discuss Dues Structure

Like any institution or association, LANJ is finding the economy has affected the financial well-being of our institution. LANJ has not changed its' dues structure since 2005 and now finds it necessary to update their rate structure for 2013. The board has had in-depth debate and discussion over the last couple of weeks and has sought the advice and counsel of the NLA and TLPA for ideas. Paul Rosenberg, board alternate, has been very helpful with the board deliberations and is advising the executive board on new approaches as used by the TLPA. One approach that has been discussed is to set up dues renewals on a monthly basis through automatic credit card processing, which may help members with a payment plan versus a one -time fee. The board hopes to have the new dues structure in place by the first of the year and is making a determination when/if monthly dues payments may be made by automatic credit card deduction. More news on this will be forthcoming once the details have been worked out.

Chauffeur Training School Could Become Reality

Many operators have come to LANJ about the problem of finding qualified drivers. The turn-over rate in the industry is over 10%, thus causing a shortage. LANJ executive director, Barry Lefkowitz, has initiated discussions with Burlington County College president, David Hespe, about establishing a Chauffeur Training Certification program for South and Central Jersey. This is viewed by many as a way of creating a more professional driver and adding some luster to the position. A meeting will be held with president Hespe early January to pursue the potential certification program. Don Kensey of Cross Keys Coach will chair the committee, along with Jim Moseley. LANJ will work with the Division of Business Services, NJ Department of Labor and Workforce Development. NYC is setting up a test with apps, which was heavily fought by LANJ and its partners in COTA. Originally the apps were going to be voted down by the TLC commissioners. Unfortunately they are moving forward by conducting this pilot test. We all recognize that modern technology brings about change but we must insist all those who participate in the industry play by the same rules. Certain app companies are skirting the rules and regulations significantly. The TLPA and International Association of Transportation Regulators have agreed to work together with COTA, and others, in preventing the rogue apps from destroying our industries.
