# LANJ Moving Towards Chauffeur Training Program February 28, 2013

The Chauffeur Training Certification Program Committee, Chairman Don Kensey, Crosskeys Coach and Co-Chair Jim Moseley, Trip Tracker Software, along with Barry Trabb, Complete Fleet, Martin Ross, Ross Limo and Barry Lefkowitz, LANJ Executive Director, met with David Hespe, President of Burlington County College, Dr. David Spang, Vice-President for Academic Affairs and Rebecca Corbin, Dean of the Corporate College to discuss the creation of a "Chauffeur Training Certification Program" for the limousine industry.

The participants had a lengthy but very fruitful discussion regarding creating a program that would meet the on-going needs of our industry and be easily accessible for the entire state. It was determined that a hybrid program, on-line classes with a full Saturday training seminar would work best for New Jersey operator's needs. President Hespe and LANJ are looking to work with the NJDOL and the Workforce Investment Board to provide scholarships and funding for the program. LANJ shared with the college leadership existing materials, including tapes and DVD's for training produced by Tom Mazza, a revered

name and brand deeply associated with the U.S. limousine industry. It is anticipated that there will be a follow up meeting with the college in mid-March.

### LANJ to Roll Out New Affinity Programs for Cost Savings to Members February 28, 2013
