#### LANJ Aggressively Pursues Jitney Illegal Actions July 25, 2013

New Jersey Assembly Bill 3993 is legislation designed to deal with the illegal activities by Jitneys operating out of Atlantic City, as well as Hudson, Bergen and Union Counties, NJ.

Members of the Transportation Committee and prime sponsors of the bill are Assemblyman Charles Mainor, Assemblywoman Angelica Jimenez, Assemblywoman Marlene Caride and Assemblyman Scott Rudder.

Although Jitneys in Atlantic City are only to be operating on a fixed route and can only conduct business in the four contiguous municipalities adjacent to Atlantic City, they have taken to doing business at the Atlantic City International Airport, charter work to include weddings, proms, concerts, sporting events and other venues not within their regulatory authority, along with conducting interstate trips.

The North Jersey Jitneys do not meet the definition allowed by state law in order to be classified as a Jitney. Companies are renting out "Jitneys" to drivers who do not possess a commercial driver license. The issue gets down to enforcement.

LANJ Executive Director, Barry Lefkowitz recently met with Assemblyman Charles Mainor, prime sponsor, along with Assemblyman John Amodeo, who's District has Jitneys and officials from Atlantic City's Licensure Bureau responsible for ground transportation in the area.

The general consensus by all parties is that the legislation was necessary and that there needed to be strong sections added encompassing fines, enforcement by local, county and state law enforcement officials, strengthening the existing state law so that there is no ambiguities regarding how Jitneys are allowed to operate, increasing insurance requirements for Jitneys operating as they were meant to conduct business and finally if they want to conduct business similar to limousines they will be required to meet all rules and regulations governing our industry.

The New Jersey Bus Association has agreed to work with LANJ in seeking passage of the Bill and Assemblyman Charles Mainor is speaking with Senator Nicholas Sacco (D), Transportation Chair, to be prime sponsor of the Bill in the Senate.

### "Beach Buggies" Want to be Classified as Limos

A group of young entrepreneurs have introduced to the Jersey Shore area battery operated golf type vehicles, typically found in Celebration, Florida. These 2-6 passenger vehicles provide door to door service, pick up your laundry and a host of other services. Presently they are operating in Margate, NJ.

These types of vehicles are classified as a "low speed vehicles" by the federal government, but are not classified for commercial use and may not go over 25 mph. The Motor Vehicle Commission (MVC) has been approached by the attorney for "Beach Buggies" to have them classified as limousines since they are unable to get medallions as taxis, which would be a more appropriate classification for them.

Jeff Shanker, Legislative Chair and Secretary of the LANJ Board and LANJ Executive Director, Barry Lefkowitz recently had a major conference call with the MVC General Counsel and Legislation Liaison. Both made it very clear that MVC would be opening itself up to a host of problems and issues if they allowed these vehicles to be classified as limousines. Jeff Shanker provided them specific statutory cites to demonstrate our points. Additionally, putting OL plates on them would allow them to go over the 25mph speed limit, have open containers and a host of other rights that the law should not allow for "Beach Buggies."

They have taken all of our information under advisement and will call upon us if they need further information and material.
