LANJ at Forefront of Jitney Legislation

September 26, 2013

On September 23, LANJ Board Secretary/Legislative Chair Jeff Shanker and Vice-President James Moseley, testified in front of a special hearing of the NJ Assembly Transportation Committee held in Hoboken in favor of the bi-partisan bill A3993 sponsored by Assemblyman Charles Mainor and several other members of the Assembly. Board Member Paul Rosenberg was in attendance supporting LANJ's efforts and being available as an expert witness on the Atlantic City Jitneys.

The Assembly Committee, which took testimony from, federal (FMCSA), state officials and stakeholders as a whole appear ready to move legislation to correct the serious safety problems presented by North Jersey jitney-buses and AC jitneys in South Jersey. The legislature wants to correct the obsolete laws surrounding jitney-buses and the AC jitneys and their operation. The foundation of LANJ's testimony focused on safety issues and jurisdictional authorities which are permitting the illegal operation of these vehicles which include issues of: enforcement ability of local, county, and state law enforcement officials utilizing "probable cause," the implementation of a CDL program with criminal background checks, drug and alcohol screening for all drivers and a fine structure established similar to the limousine law.

Testimony was heard from the Atlantic City Jitney Association President, Tom Woodruff, where he stated they recognized they are operating as a monopoly in the Atlantic City area. Further, they clearly stated they have been operating across state lines (illegally), especially with the Miss America Pageant with 14 jitneys picking up at Philadelphia International Airport and took people to Atlantic City with only one vehicle having USDOT Authority. They creatively (illegally) leased out the authority of one vehicle for the remaining 13. Can you imagine if a limousine company did that!!!

Woodruff stated that jitneys only operate 15 days a month in Atlantic City and in the nearly 100 years of existence, no AC jitney has ever gone out of business or filed for bankruptcy. When challenged as to what jitneys do the other 15 days of the month, Woodruff stated "maybe they are doing charter work" (illegally).

A jitney operator from North Jersey stated she owns 98 buses in her fleet and leases out an additional

100 vehicles under her one USDOT authorized vehicle to various independent owner/operators in the area (illegally).

Assemblyman Wisniewski, Committee Chair, noted these vehicles could be producing upwards of \$225 million in revenue.

The USDOT/FMSCA was represented by Christopher Rotondo, Division Administrator for NJ. His testimony and expertise was well received and educational for the legislators. In response to how these vehicles should be classified, his response was simple...if it looks like a bus...it is a bus, whether it's 13 passengers (AC Jitneys) or more (North Jersey). He stipulated that if a vehicle does not cross state lines to transport passengers to another state, FMSCA has no jurisdictional oversight capabilities, however, if it does cross state lines, his agency does have authority.

Assemblymen Wisniewski and Mainor both personally thanked LANJ for our professionalism and proactive approach towards the entire passenger transportation industry, where we are always recognized for looking out for the betterment and safety of our passengers.

It is anticipated that the A3993 and its Senate counterpart will be brought up on the Assembly and Senate floors for a vote in the next couple of months during the "lame duck" session.
