LANJ Fight Against TNC Illegalities Wages On

LANJ leaders, including president **James Moseley**, vice president and Legislative Committee chair **Jeff Shanker**, board member **Paul Rosenberg** and lobbyist **Barry Lefkowitz**, had a very promising meeting this past Thursday October 23 with New Jersey State Senator Ronald Rice (D-28) and Assemblyman Charles Mainor (D-31), the prime sponsors of LANJ-proposed Assembly Bill 3401 written to recognize that public safety is the top priority and regulate passenger transportation companies that use an online application program to connect drivers with passengers, ensure they operate under the same rules as traditional chauffeured transportation companies and specify the penalty(ies) if they do not.

Both legislators indicated agreement with the LANJ position that public safety is the prime concern in this matter and, accordingly, reiterated their support of Assembly Bill 3401. LANJ currently is awaiting the decision from Trenton regarding the choice of review committee (Law and Public Safety Committee or Transportation and Independent Authorities Committee) and date for the first hearing on Assembly Bill 3401. LANJ members will be advised when this information is announced so they may prepare for noteworthy testimony.

Additionally, on Friday October 17, Shanker and Lefkowitz participated in the Insurance Council of New Jersey meeting where consensus was reached by attendees that New Jersey insurers do not have a policy product that "switches back and forth" between personal and for-hire coverage such as is needed in the case of UberX and other TNC providers who operate personal vehicles for commercial use. Discussion at the meeting sparked a well presented debate that provided attendees clarity regarding the public safety issue and the fiduciary requirements involved if injuries or damages occur with uninsured providers such as these.
