### LANJ Bill A3401 on TNC Legislation Goes to NJ Assembly Transportation Committee

A hearing before the New Jersey Assembly Transportation and Independent Authorities Committee regarding LANJ-proposed Assembly Bill 3401 is set for **Monday December 8 at 10 AM**. Bill A3401 is written to recognize that public safety is the top priority of professional transportation providers and, accordingly, regulate passenger transportation companies that use an online application program to connect drivers with passengers, ensure they operate under the same rules as traditional chauffeured transportation companies and specify the penalty(ies) if they do not.

All LANJ members are encouraged to attend the hearing. There will be a conference call on Wednesday December 3 at 10 AM to strategize and set the schedule of testimony.
