Verify Your CDL Chauffeurs Comply with New Federal Medical Examiner Reporting Requirements

The New Jersey Motor Vehicle Commission (NJMVC) is implementing a process that will enable chauffeured transportation companies to verify if their drivers with a CDL have complied with new federal medical examiner reporting requirements.

To get the necessary information for this, contact the LANJ member services office at patricia.nelson103@gmail.com.

By return email you will receive a report to be completed and sent to the NJMVC. The drivers listed on your report will be checked for compliance and the report will be returned to you with indication of each driver's status. Additional instructions on how to ensure your chauffeurs get entered into the medical certification system will be provided when the report is returned.

Second 2015 Renewal Notices Sent to 12/31/14 Expiring Companies

New Operator? Check Here for Your Eligibility to 2015 NLA/LCT Scholarship Program
