LANJ's Battle Against TNC Illegalities Continues Unabated in NJ Legislature

In its non-stop fight against transportation network company (TNC) illegalities, the Limousine Association of New Jersey has prepared a detailed comparison of the state's limousine statute requirements and the requirements of proposed A-3765, the floor amendment recently introduced to the New Jersey Assembly that would treat TNCs as if they are outside the traditional passenger transportation industry. As outlined in the LANJ document, the amendment permits substantial gaps in critical areas such as driver background checks, insurance requirements and vehicle inspections — all of which clearly put public safety in jeopardy.

The LANJ Legislative Committee, led by president **Jeff Shanker**, anticipate meeting with the amendment's chief sponsors, Assemblymen Joseph Lagana (D-38) and Troy Singleton (D-7), very shortly to review the specific concerns about A-3765. One-on-one meetings also are being held with New Jersey Senate officials regarding S-2742, the Senate bill that mirrors A-3765.
