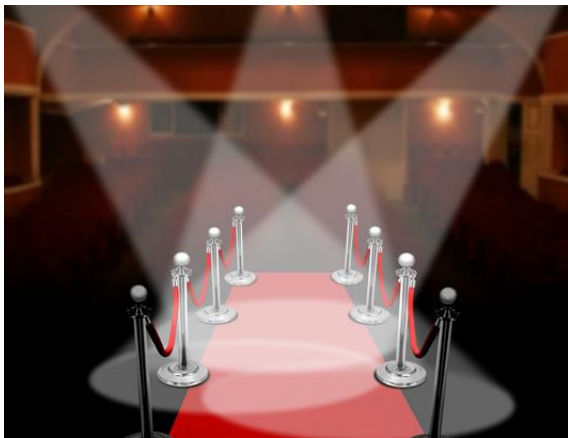

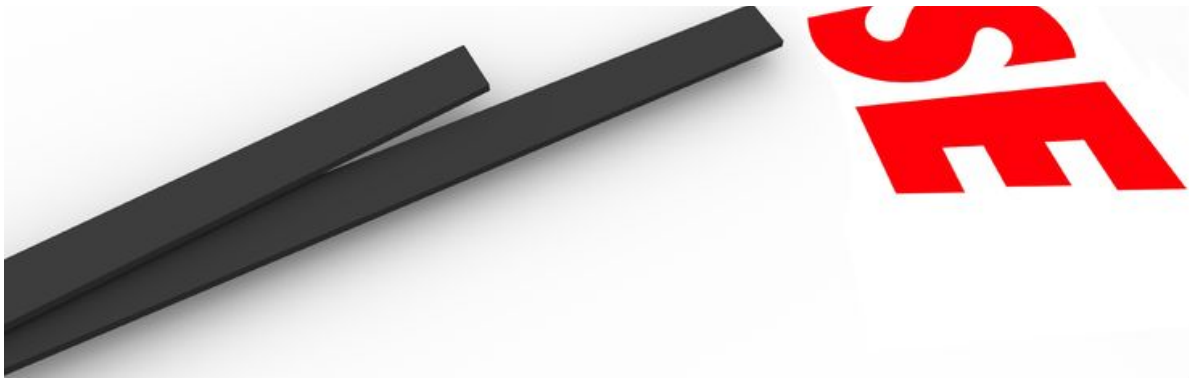

**Register by 8/31 for Bus and Van Access to Philadelphia for Pope's Visit**





To secure access to Philadelphia for the Pope's visit on September 26 and 27, 2015, **ALL** bus and van operators and drivers **MUST** be registered at [wmof.goground.com/registration](http://wmof.goground.com/registration) **by August 31**.

GoGround is the official transportation management partner of the World Meeting of Families and its [website](http://wmof.goground.com/registration) is the official registration site for all commercial charter buses and privately owned buses going to the World Meeting Congress itself (September 22-25) and the subsequent historic visit by Pope Francis (September 26-27).

Registered vehicles will have exclusive access to Stadium Complex and Camden parking. They also will have travel access to closed and restricted highways.

I-76 & I-676, and exit ramps off I-95 will be closed to traffic not bearing a parking permit issued by GoGround.

Buses originating from the Archdiocese of Philadelphia and states to the south and west will be directed to the Stadium Complex in Philadelphia and those buses from New England, New York and New Jersey will be directed to Camden. Requests for either location will be honored.

- \* **Time-sensitive next steps** for already-certified operators (**critical to receive permits**)

**There are no exceptions to these requirements.** ALL buses and qualifying passenger vans traveling to Philadelphia for the Papal visit must be registered. **ONLY** registered buses will have access to restricted routes and parking. **Unregistered vehicles will be turned away and may be subject to fines.**
