### How to Fight TNC Illegalities in Your Own Municipality Right Now

Want to fight TNC illegalities in your own backyard...right where they're hurting your company the most?

Be a copy cat!

Take the resolution recently passed by the West Windsor Township Council to your own municipality and request its governing body pass a similar resolution. Then do whatever it takes to ensure the town forwards the resolution to the district's state senator and assemblymen so it will be taken into account in the New Jersey General Assembly's legislative process.

Simple and straightforward, the resolution mimicks 2015 bill A3675 which has been introduced to the General Assembly for 2016 as A609/S858 and pledges "support of laws establishing identification, insurance and safety requirements for companies that use digital network or software application to match passengers with drivers."

Going forward with this action step is especially critical if your locale has transportation hubs and/or entertainment venues within its boundaries.
