## Limousine Association of New Jersey

### LANJ Board Adds New Affiliate Member Category for Non-NJ Operators



At the group's July 27 conference call meeting, the Limousine Association of New Jersey board of directors approved "Affiliate Membership" as a new membership category for the organization.

LANJ Affiliate Membership is open to any chauffeured transportation operating company that has its primary place of business outside the State of New Jersey.

The purpose of Affiliate Membership is to forge and/or strengthen affiliate

relationships between chauffeured transportation operating companies so located and LANJ Regular Active Members (operator members).

LANJ Affiliate Membership includes many entitlements, prominently: 1) opt-in to The LANJ Line to utilize its "Instant Job Trade" and "Bulletin Board" capabilities for farm-in and farm-out work with LANJ Regular Active Members; 2) receipt of all association communications, notably twice monthly **LANJ E-News** and periodic **LANJ E-Flash** issues; and 3) Affiliate Member listing with full company contact information on LANJ.org.

Affiliate Members are not entitled to hold an elective office in the association, vote in the annual board elections or participate in the voting process on any matter that is put up for vote to LANJ Regular Active Members and Allied Trade Members.

Dues for Affiliate Membership in the Limousine Association of New Jersey are

Dues for Affiliate membership in the Limousine Association of New Jersey are \$500/year.

Should an operating company that has its primary place of business outside the State of New Jersey want to join LANJ as a Regular Active Member, rather than as an Affiliate Member, it may do so. In this case, the company's annual dues will be the current rate for its fleet size and the company owner/manager will have all of the rights, e.g. elective office, voting, of a Regular Active Member.

LANJ will begin promotion of this new membership opportunity in mid-September. All LANJ operator and supplier members are encouraged to invite their affiliates and customers to participate.

## **LANJ Annual Dues for One-Car Operators Reduced to \$150/Year**

In addition to the above, the LANJ board of directors also approved on July 27 a \$100 annual dues reduction for one-car operator members from the current \$250/year.

Effective immediately, annual dues for new one-car operator members will be \$150/year. Annual dues for current one-car operator members will be \$150/year at the time of their next membership renewal.

The LANJ board of directors intends this change to attract as members more chauffeured transportation owners who recently have launched their businesses as well as owners who, while operating just one vehicle, want to demonstrate their professionalism with affiliation to the Limousine Association of New Jersey.
