like is a question and concept that is closer to being answered after the Port Authority of New York and New Jersey named a leading aviation planning and design company and a leading architectural firm to do that work..." reported **NJ.com** late last month.

"Officials named **Arup**, a global top aviation planning and design firm, to partner with leading architecture firm **Skidmore, Owings & Merrill**. The selection ends a process started in April to find a master planner with airport experience to oversee architectural, planning, engineering and business development for the next phase of Newark Liberty's redevelopment.

"This overhaul will produce the world-class facilities befitting of one of the most pivotal transportation hubs in the world,' Gov. Phil Murphy said in a statement. 'By selecting internationally renowned firms Arup and SOM to oversee the Newark vision plan, the Port Authority has demonstrated its intent to help Newark Liberty reach its maximum potential for the benefit of all residents and visitors.'"
