NJ Attorney General Limits Background Check Requirements for TNCs

On October 31, 2017, then New Jersey Attorney General **Christopher Porrino** made the decision that a driver's name and social security number are the only information required for transportation network company (TNC) driver background checks. Fingerprinting, as long advocated by the Limousine Association of New Jersey, was not deemed to be a requirement.

It should be noted, however, that this decision could be reversed by the new Attorney General **Gurbir Grewal** who was appointed to the position by Governor Phil Murphy this past January.

LANJ leaders and principals of the organization's lobbying firm Kaufman Zita Group are continuing their efforts to secure such a reversal so that TNCs will be regulated in this regard just as chauffeured transportation companies are and also, very importantly, that the public which is transported by TNCs will be far safer than it is currently.
