For Your Attention! National Transportation Safety Board Guidelines

All operator, affiliate and endstage manufacturer members of the Limousine Association of New Jersey are urged to ensure their companies' adherence to the National Transportation Safety Board (NTSB) guidelines.

As published in the *Special NLA Bulletin* on November 16, 2018, they are as follows:

* "Per NTSB recommendation H-15-20, the NTSB recommends that operators do the following during pre-trip safety briefings:

- * Direct passengers to use seat belts where required by law.
- * Strongly encourage passengers to use seat belts where not required by law.
- * Encourage passengers to use properly adjusted head restraints.
- * Decline passengers and luggage if their cumulative weight is in excess of the manufacturer's stated capacity.

* Per NTSB recommendation H-15-21, the NTSB encourages end-stage manufacturers to post the total passenger and luggage weight limit on any vehicle altered as part of the vehicle-altering and final-stage manufacturing process."

Additionally, as also reported in the November 16 *Special NLA Bulletin*, the National Limousine Association "recommends that all members implement standard passenger safety briefings prior to the commencement of each trip. These briefings, to be conducted by the driver, will serve to inform passengers of the location of safety restraint belts, fire extinguishers, first aid kits, and if applicable, location and operation of all emergency exits."
