Featured are: 1) LANJ president Jason Sharenow's report on the **Port Authority's Privilege Permit - For Hire Vehicle (FHV) services fees at EWR, JFK and LGA** that will include a substantial initial fee plus per-trip access fees for chauffeured transportation companies and other entities accessing the region's three major airports; and 2) Strategy Leaders' principal Robyn Goldenberg's presentation on **Paycheck Protection Program (PPP) forgiveness and second draw funding and CERTS Act emergency relief funding to motor coach operators.**

Important Update on the Privilege Permit: Positive progress is being made to address many of the concerns expressed during the webinar about the new Port Authority requirements. LANJ should receive some definitive answers within the next week or so. Watch this space!

In Memorium: Industry's Denise Cali and Luis Rosario

In the last several weeks, the chauffeured transportation industry has lost two of its own: **Denise Cali**, owner with her husband John, of J & J Transportation in Allentown, who died very unexpectedly on January 15, and **Luis Rosario**, general manager of Avalon Chauffeured Services' New York City operation, who succumbed at age 37 to post-COVID complications on January 23.
