## **New Jersey's Statewide Minimum Wage Increased to \$13/Hour on 1/1/2022**

As reported in multiple news outlets over the last several weeks, New Jersey's statewide minimum wage, which impacts most employees in the state, increased \$1 to a total of \$13/hour on January 1, 2022.

According to **New Jersey 101.5** online late last year, "This mandate is part of legislation signed by Gov. Phil Murphy in February 2019, which gradually raises the minimum hourly wage to \$15 by 2024."
