Latest from Port Authority: Updated FHV Permit Payment and Reporting Requirements

The Limousine Association of New Jersey recently received an **update on FHV Permit payment and reporting requirements** from The Port Authority of New York & New Jersey. Specifically, it noted:

- **Monthly Reporting:** One of the requirements of the FHV permit is submission of a monthly report with the respective payment. The information to be included in the report is as follows: FHV Base Number, FHV Base Name, PANYNJ Permit Number, Driver FHV License Number, FHV Motor Vehicle License Plate Number, Transaction Type (Airport Pick-Up, Drop-Off), Transaction Date, Transaction Time, Transaction Payment Type, Product Type, Trip Size, Airport, Terminal. It is recommended that a template, e.g., Excel spreadsheet, be created with these categories so the data can be submitted consistently each month. The report should be emailed to PermitFHV@panynj.gov.

The Port Authority advises it is currently exploring a more streamlined reporting process and/or portal that will be used for future reporting of fees and payments. When this has been completed, another update will be provided.
