LANJ Receives \$8,500 Grant from NLA



The Limousine Association of New Jersey is very pleased to announce that the organization just has been awarded an \$8,500 grant by the National Limousine Association (NLA) under the NLA's new Association Grant Program.

The Association Grant Program, which is planned to be an annual one, replaces the NLA's previous rebate program which was offered to all NLA member regional and state associations that for many years afforded LANJ 20% of NLA dues collected from its operator member companies that also were NLA members.

The amount of the Limousine Association of New Jersey grant was determined by LANJ's application which detailed how the funds would be used for state lobbying efforts and other initiatives that support the chauffeured transportation industry in New Jersey. All regional and state association members of the National Limousine Association were eligible to apply for the Association Grant Program awards.
