The meeting was called to order at 10:05 AM.

**President's Report**

- **Upcoming Board Meeting**  
Sharenow announced that the next board meeting would be held by Zoom on Wednesday May 19 at 10 AM ET.
- **Golf Outing on 9/14/2021**  
Sharenow also said that a "micro" golf outing (40 golfers maximum), sponsored by LANJ, will be held midday on Tuesday September 14 at the Brooklake Country Club in Florham Park. A barbecue dinner, which will include an educational component and to which all LANJ members will be invited, will follow. Golf and dinner guests will be charged \$175 and \$60, respectively. A small committee will be formed to help plan the event.
- **Port Authority Permit**  
Sharenow advised board members to email their Port Authority permit applications rather than sending them by USPS or FedEx to ensure prompt receipt and processing. He also encouraged all operators to act as if they have the permit, e.g., collect fees from clients, even if they have yet to actually receive it.

- **Dues Suspension**

Sharenow elicited discussion regarding LANJ's current dues suspension which was launched on April 1, 2020. Agreement was reached to table the topic until the May 19 meeting when the discussion can be taken up once again. Donohue noted that the Philadelphia Regional Limousine Association has suspended its dues for all of calendar 2021.
